2. Hazards identification

3. Composition/information on ingredients

There are no ingredients or additional ingredients present which, within the current knowledge of the supplier and in the concentrations applicable, are classified as hazardous to health or the environment and hence require reporting in this section.

4. First aid measures

First aid measures

- General** : In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person.
- Inhalation** : Remove to fresh air. Keep person warm and at rest. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. Give nothing by mouth. If unconscious, place in recovery position and seek medical advice.

5. Fire-fighting measures

- Extinguishing media** : Recommended: alcohol-resistant foam, CO₂, powders, water spray.
Not to be used : water jet.
- Recommendations** : Fire will produce dense black smoke. Exposure to decomposition products may cause a health hazard. Appropriate breathing apparatus may be required. Cool closed containers exposed to fire with water. Do not release runoff from fire to sewers or waterways.

6. Accidental release measures

- Personal precautions** : Avoid breathing vapor or mist. Refer to protective measures listed in sections 7 and 8.
- Spill** : Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see section 13). 7. Handling and storage

- Handling** : Keep container tightly closed.
- Avoid contact with skin and eyes. Avoid inhalation of vapor, spray or mist.
