Controlled foam and free-rinsing characteristics assure that no residue is left behind to interfere with subsequent finish applications.

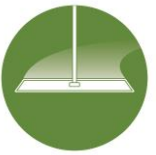

**DIRECTIONS:** DO NOT USE BONA COMMERCIAL SYSTEM™ RESILIENT FLOOR HEAVY DUTY STRIPPER ON LINOLEUM FLOORS. FOR LINOLEUM FLOORS USE BONA COMMERCIAL SYSTEM RESILIENT FLOOR STRIPPER (ITEM# WM700064001). Sweep or dust mop the floor to remove any debris. Dilute Bona Commercial System Resilient Floor Heavy Duty Stripper to 1:4 with room temperature or mildly warm water, depending on age and build-up of finish. Apply liberally with a

mop to an area small enough so as not to allow the product to dry. Be sure to completely cover floor to baseboards. After 3 to 5 minutes, Use 80 to120-grit Bona Diamond abrasives with the Bona MultiDisc over 3' x 5' section of the floor. Pick up solution using a mop, wet vac or automatic scrubber. Rinse thoroughly with clear water to neutralize the floor and remove residue as necessary. Once dry apply Bona Commercial System Resilient Base Color or Resilient System Floor Finish. See Bona Commercial System Resilient Base Color or Resilient System Floor Finish, for detailed instructions. Asphalt tile and rubber flooring could be affected by stripping solutions in high concentrations with hot water. Always test floor before proceeding.

### Maintenance

**CLEAN-UP:** Clean all tools and equipment with warm water.

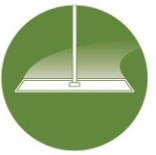
**STORAGE:** Close container after use. Store in area inaccessible to children.
